

Totino's™ Forza Motorsport 7 In-Game Content Offer

PROGRAM TERMS AND CONDITIONS

1. Eligibility: Totino's™ Forza Motorsport 7 In-Game Content Offer (the "Program") is open to legal residents of the fifty (50) United States (including D.C.), eighteen (18) years old or older at the time of entry. Employees of General Mills Sales, Inc., HelloWorld, Inc., and their parent and affiliate companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee, are not eligible. Void where prohibited.

2. Timing: Program begins on October 15, 2017 at 12:00 a.m. Central Time ("CT") and ends on April 30, 2018 at 11:59 p.m. CT (the "Program Period"). Administrator's computer is the official time-keeping device for the Program.

3. P.O. Boxes are not permitted. Then, follow the links and instructions on the Website to submit the Code and select which Totino's Pizza Snacks Product you purchased.

The first Code you enter, you will receive a Forza Motorsport 7 in-game liveried car. Approximate Retail Value ("ARV") of Offer: \$\$1.50.

The second Code you enter, you will receive a Forza Motorsport 7 in-game driving gear pack. ARV of Offer: \$1.50.

The third Code you enter, you will receive a second Forza Motorsport 7 in-game liveried car. ARV of Offer: \$1.50.

If you enter a Code found on a package of 120ct pizza rolls or a Party Pizza Pack, regardless of when the Code is entered, you will receive a Forza Motorsport 7 in-game driving gear pack. ARV of Offer: \$1.50.

Limit: One (1) of each type of Offer. Multiple participants are not permitted to share the same email address. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by participants, printing errors or by any of the equipment or programming associated with or utilized in the Program; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the registration process or the Program; (4) technical or human error which may occur in the administration of the Offer or the processing of registrations; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from participation in the Program or receipt or use or misuse of any Offer.

Disputes: Except where prohibited, participant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Program or any Offer awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Program, but in no event attorneys' fees; and (3) under no circumstances will participant be permitted to obtain awards for, and participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Terms and Conditions, or the rights and obligations of the participant and Sponsor in connection with the Program, shall be governed by, and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
